#### 1.4. Treasurer's Report

Ron Schott, Treasurer, circulated via email the Desert Financial Credit Union statement with account and transaction details for Board reference, which are included at the back of these Minutes. Ron reported that current funds on hand total \$11,778.29 with no major recent expenses. The only charge was the CenturyLink bill. Mark commented that the Directors & Officers Insurance will be due sometime in the summer.

The current balance in the AZBSN Task Force account is approximately \$22,000. Steve has launched a sponsorship drive.

Mark has said previously that ATIC needs to pursue its own funding, which would include sponsorships. ATIC needs to initiate a financial campaign for sponsors and other sources of funding to support and undertake new projects.

#### 1.5. ATIC Board Membership Considerations

Mark again noted that we have an ongoing interest in acquiring more representation from rural communities and tribal organizations. However, there is nothing new to report on this front.

We have twenty-four Board members. We can have up to thirty-five according to our bylaws.

Mark noted in a previous meeting that Robert Gallegos is the IT/Security Director for the Northern Arizona Council of Governments (NACOG) and wants to be more involved with the Arizona Broadband initiatives. Joy Whiting, Apache County Schools Superintendent who participates in the AZBSN task force, is a potential person Mark could contact to join the ATIC Board.

Mark remains committed to talk to Toni Broberg of AT&T and Gene Carl of Cox about becoming ATIC Board members and sponsoring ATIC or AZBSN.

#### 1.5.1. ATIC Officers Election at April 13, 2022, Board Meeting

Mark noted that we need to do our annual election of officers at the April meeting. Five positions are up for election. They are:

Chair: Mark Goldstein (Incumbent)
Vice Chair: Henry Goldberg (Incumbent)
Secretary: Oris Friesen (Incumbent)
Treasurer: Ron Schott (Incumbent)

Lobbyist: Mike Keeling (Acting but prefers not to run)

Mark, Henry, Oris and Ron agreed to run again.

MOVE: Derek Masseth SECOND: Kirk Busch Passed Unanimously

Mike Keeling will continue to serve as acting Lobbyist since no-one volunteered to run for this position.

#### 1.5.2. ATIC Broadband Providers Working Group Meeting on April 6, 2022

An outcome of the January ATIC Board meeting was to create an ATIC broadband service provider working group whose function would be similar to a trade association since there is no telecom service provider trade association in Arizona. The goal of this working group would be to focus on addressing common issues and opportunities for the broadband service providers in Arizona.

Mark reported that consequently, we created a special breakout session at the BigData Southwest DataCenter & SmartCity IoT Infrastructure Summit (<a href="https://www.bigdatasw.org/">https://www.bigdatasw.org/</a>) on April 6, 2022, to launch such an ATIC working group. It was a hybrid event held at the Desert Willow Conference

Center in Phoenix. There were about eleven attendees in the room and five on-line as employees or representatives of broadband providers. Mark, Henry, and Steve Peters attended this session. After introductions we discussed what tasks the group should address. There was limited interest expressed in forming coalitions for advocating for rights-of-way and pole placements, but several attendees suggested provider-to-provider information sharing and opportunities for the formation of partnerships would be of value. The participants advocated for a semi-private forum to exchange information. They also expressed a preference for asynchronous communication. Slack was suggested as a possible communication medium for this and Mark will further explore with Rory Conaway of Triad Wireless.

Mark discussed the broadband provider spreadsheet that he created consisting of contact information for about 142 individuals at some 100 or so companies providing broadband services in Arizona. He will share this list with a limited number of people to critique and edit. Mark described the contents and noted that several columns need to be filled in to show what broadband technologies for last-mile access and middle-mile networks the companies provide. He proposed creating an interactive page on the ATIC website that would reference this spreadsheet and respond to a search of solutions that a given organization provides. Mark noted that he wants to be careful not to provide contact information for providers which they do not want shared with the public. Mark gave credit to Jeff Sobotka who contributed to an earlier version. Mark is willing to maintain the list. Steve asked if broadband providers responding to state RFPs could also be a source, but Mark replied that ADOA does not release such a list.

Mark asked for comments. Henry and Derek suggested adding the attributes of market served and the region/geography that is covered. Steve replied saying that we need a good list of providers which should include attributes such as the company name, area covered and one or two contact names. Steve suggested getting ASU, specifically Erin Carr-Jordan and Barnaby Wasson to help flesh out this content perhaps utilizing interns. Steve added that this Excel spreadsheet could be converted to a Google sheet to be posted on the ATIC and AZBSN Task Force websites depending on its planned applications.

Steve noted that a number of broadband providers also are providing digital inclusion offerings, and Mala said that the Connect-Arizona website is already in the process of creating a digital inclusion directory

Mark will work with Rory Conaway and others to create a Slack channel and he will contact and coordinate with a woman in Tucson who is creating a similar list if companies. Mark will also talk with Jeff Sobotka on how the broadband provider spreadsheet could be best used.

#### 3.1.1. Rural Community Outreach

#### 3.1.2. ACA Broadband Strategy & ATIC Role/Support

Jeff Sobotka, State Broadband Director at the Arizona Commerce Authority (ACA) was not present and Mark provided a summary update of activities.

Mark reported that Jeff is still evaluating over eighty responses to the ACA Arizona Broadband Development Grant Program (ABDG) solicitation of \$100 million in funding (\$75 million for rural counties and \$25 million for urban counties). The ABDG grant awards should be announced by June 30. Heather Floyd asked about the dates of the challenge period. Derek suggested that she should reach out to Teri Orman, the Grants & Procurement Manager for the ACA, about those dates.

Mark noted that Sandip Bhowmick has been appointed Assistant State Broadband Director, reporting to Jeff Sobotka.

Mark attended the Fourth Navajo Nation Broadband Initiative Meeting on March 18 with state broadband directors from all four-corner states in attendance as well as the Navajo Tribal Utility Authority (NTUA), which provides communication infrastructure for the reservation, and other Navajo Nation representatives. It was a three-hour meeting with roughly twenty-five in-room and fifteen remote attendees. The Navajo Nation has \$208 million to be allocated to broadband initiatives, including \$57 million available for chapter house fiber connectivity, digital equity, community engagement, etc.

#### 3.2. Arizona Broadband Stakeholder Network (Steve Peters)

#### 3.2.1. ASBSN COVID-19 Digital Access Task Force Updates

Steve reported on the activities of the AZBSN COVID-19 Digital Access Task Force meetings.

The Task Force continues to meet every Monday morning with representation from broadband service providers, technology companies, state and local government agencies, educational organizations, non-profits and consultants. These meetings provide information on what is going on in the state in the digital access area as well as great opportunities for collaboration. Steve explained that a major benefit of the task force is to build relationships among participants for future collaboration, and he is experimenting with different formats to facilitate collaboration.

Steve is highlighting new announcements of events and resources on the Task Force website to provide a newsletter style information sheet.

The Task Force receives regular updates from state organizations: ACA (Jeff Sobotka), ADE (Milan Eaton & Shelby Brown on E-rate, and the new Office of Digital Teaching & Learning), the Arizona State Library, and the Sun Corridor Network (Derek Masseth). Steve complimented ADE, the Arizona State Library and the Schools, Health & Libraries Broadband (SHLB) Coalition who are growing in influence and have been very active. He noted that cybersecurity still needs to be addressed in a meaningful way. This is especially true because of the large number of new people who are coming online.

Steve said some task-oriented working teams are being formed to focus on specific topics, such as a digital inclusion network team chaired by Cindy Hogan and Nicole Umayam. This is leading to increased collaboration and mutual support for digital inclusion capabilities among practitioners, and developing inputs for the State Digital Equity Plan funded by the federal IIJA.

Nan Williams serves on the EDTech Committee for the Arizona Department of Education (ADE) which is rewriting the Educational Technology standards this year. She is also participating in the ADE Technology Task Force on the Digital Learning Subcommittee and she is part of the ISTE policy group on digital equity access. She has also been working with the Arizona Rural Schools Association and their Final Mile Project (https://www.finalmileproject.com/).

The event will be held on May 6, 8:30-3:00, at the Balsz Community Center, 4309 E. Belleview St. Bldg. 14, Phoenix, AZ 85008, and will be an in-person event. The symposium is a one-day event that will bring together educational leaders from across the state of Arizona to explore the challenges and share the successes that exist between Teaching, Learning, & IT.

#### 3.3.2. GAZEL Innovative Learning Collaborative Initiatives

The GAZEL Board still needs to purchase D&O insurance.

Work to produce a Memorandum of Understanding (MOU) between GAZEL and ATIC on the AZBSN has been on hold and a determination should be made about whether this is still necessary and if so, how to accomplish.

#### 3.4. Arizona State Library (Holly Henley, Mala Muralidharan)

Mala Muralidharan, E-rate Administrator for Public Libraries at the Arizona State Library, reported on her and Arizona State Library recent activities. She noted that the E-rate application filing window for next fiscal year funding closed on March 22, 2022. Roughly \$120 million has been applied for. Last year Arizona made up 3.9% of the nation-wide awards. Over the last five years there has been a decrease in funding for Internet access and usage. This is attributed largely to prices that have been dropping due to competition and economies-of-scale from new technologies and consortium applications.

She said the Navajo Nation is submitting some chapter house E-rate applications. Sixty percent of the chapter houses are already connected. They have difficulties with poles falling down and chapter houses needing repairs. All facilities have at least one computer. Chapter Houses are functioning as libraries for E-rate purposes, and the Arizona State Library is providing them with electronic resources, and training will be provided at Diné<sup>i</sup> College or another training center. All facilities have Internet connectivity, and they are building the middle-mile and last-mile fiber connectivity.

The FCC Emergency Connectivity Fund (ECF) service deadline has been extended to June 30, 2023. ECF funding provides for a laptop and hotspot for those who do not have "sufficient internet access." The FCC has granted a third window for ECF applications, with a May 13, 2022, deadline.

Arizona has been successful in enrolling low-income households in the FCC Emergency Broadband Benefit (EBB) program, which has been transitioned to the Affordable Connectivity Program (ACP). There is an Arizona ACP outreach kit. Due in part to the influence of AZBSN a flyer in multiple languages has been

created and used by Connect Arizona. and navigators are available to inform and assist users. Arizona is about #11 nationally for households that are signed up. Roughly 4000 households per week are enrolling in ACP and Arizona has a total of about 230,000 households enrolled so far.

ACP The Affordable Connectivity Program is an FCC benefit program that helps ensure that households can afford the broadband they need for work, school, healthcare and more. The benefit provides a discount of up to \$30 per month toward internet service for eligible households and up to \$75 per month for households on qualifying Tribal lands. Eligible households can also receive a one-time discount of up to \$100 to purchase a laptop, desktop computer, or tablet from



participating providers if they contribute more than \$10 and less purchase price.

The Affordable Connectivity Program is limited to one monthly service discount and one device discount per household. Eligible households must both apply for the program and contact a participating provider to select a service plan.

#### **FCC Announces Third ECF Window**

The third Emergency Connectivity Fund (ECF) Program application filing window will open on Thursday, April 28, 2022 and close on Friday, May 13, 2022, at 11:59 p.m. ET. During the third window, schools and libraries will be able to request ECF Program support for eligible equipment and up to 12 months of services that will be received or delivered between July 1, 2022 and December 31, 2023 for off-campus use by students, school staff, and library patrons with unmet needs. Please see the Public Notice (DA 22-309) for additional information about the third application filing window, the service delivery date, and invoice filing deadline applicable to equipment, other non-recurring service, and recurring service requests submitted during this filing window.

#### 3.5. Telehealth (Janet Major)

Janet Major, Associate Director for Innovation and Digital Health, Arizona Telemedicine Program and Southwest Telehealth Resource Center (<a href="https://telemedicine.arizona.edu/">https://telemedicine.arizona.edu/</a>), is the lead for the Arizona Telehealth Broadband Action Team (BAT).

The Telehealth BAT, chaired by Janet and Jeff Sobotka, meets monthly on the first Tuesday of the month. There are 75 invitees and roughly half participate regularly. The BAT is looking to identify counties that need assistance.

Janet was unable to attend so Mala reviewed the status of the telemedicine in libraries Pima County project in Ajo and Arivaca on which she and Janet are working. She noted this project is taking longer than expected. Libraries are equipped with laptops, healthcare kits, and Internet connectivity to enable patients to connect with their healthcare providers. When implemented, libraries can use this program as training hours for student nurses. Laptops, instead of iPads, are being used to allow for erasure of personal data in accordance with HIPAA requirements. Phase 1 will include training in post- and pre-natal care. The next phase will provide a "loaner" device and a health-kit that can be taken to the user's home. The team is also looking at expanding this program to use bookmobiles in Mohave County and the Navajo Nation. Henry asked if it is more efficient for patients to travel to libraries than directly to their healthcare provider, and Mala responded that patients would need to travel long distances to their healthcare providers and it is also easier to get telemedicine appointments.

Partners in this effort include Care1st Health Plan Arizona and the University of Arizona among others. The collaboration enabled by AZBSN has been very useful. The official inauguration of the program is scheduled for June 16 or 17 and the team is looking for nearby acceptable venues. The inauguration will feature mini-health screenings, registrations for healthcare and other activities. Mala said they are steadily moving forward and hope to have some resultant data to report by September 30. They are also looking for more sponsors.

Janet submitted a written statement saying she was very excited to have met this morning with Care1st Health Plan Arizona and their southern Arizona partner Arizona Complete Health. She noted that as we move toward the kick-off date and event in June, the project members are very excited to be going forward with purchasing technology, creating protocols and bringing partners to the table to help make this a successful pilot that can be replicated throughout Arizona.

Janet also provided information about the Annual American Telemedicine Association (ATA) Conference & Expo on May 1-3 in Boston or via remote

link at https://www.americantelemed.org/eAnnual.

#### 3.6. Government Affairs (Mike Keeling, Mark Goldstein)

Mark said he and Ron Schott track legislative action for the Arizona Technology Council (AZTC). The state broadband office, when approved by the governor, will be situated under the ACA, as Jeff Sobotka currently reports to Sandra Watson there. As a statute this would solidify the broadband office within ACA. Currently it is a creation by executive order of the governor, It is expected to be approved since it does not require any additional funds (there is \$5 million for this Broadband Office from US Treasury funding). Heather reported the current status is that the Senate will be considering this bill in the near future.

Regarding federal funding, Mark speculated that the US Treasury money (\$192 million with a broadband infrastructure focus) will be available for Arizona use sooner than the much larger IIJA BEAD state block grant, whose allocations are dependent on the new FCC broadband maps with a more granular data fabric expected to become available late this year. Thus, Arizona broadband grant opportunities from BEAD funding are likely not to be available until 2023.

There is also digital equity money available under the IIJA Digital Equity Act and AZBSN is rallying around assisting the state in planning for its use.

In a recent Broadband Breakfast interview, Alan Davidson, the Assistant Secretary for Communications and Information at the U.S. Department of Commerce indicated that this level of funding is generational and needs to be leveraged for maximum impact. The NTIA's Notices of Funding Opportunity (NOFOs) for BEAD funding as well as for a new \$1B Middle Mile grant program are due to be issued by May 16. Mark feels that Arizona will likely be in top ten states regarding funding allocations with one recent estimate putting it at \$1.34B (https://mikeconlow.substack.com/p/hypothetical-bead-funding-for-states?s=r).

#### 4. Information and Action Plans

#### 4.1. ATIC Website & Teleconferencing (All)

As noted previously by Mark and Steve, the ATIC website is aging a bit. For example, the resources page is out of date. The website needs to be leveraged to publicize the COVID-19 Digital Access Task Force Report recommendations as well as using it for communications and public engagement, such as newsletters.

#### 4.1.1. AZBSN Communications & Newsletter

Mark at a previous meeting suggested that we should think about how to leverage some of the information sessions from the Monday morning AZBSN-COVID Digital Access Task Force meetings.

There remains a continuing need for volunteers to work

- (1) on regular maintenance of the Weebly ATIC website and
- (2) on providing a regular newsletter about all that's going on in the broadband world.

#### 4.2. ATIC Mailing List & CRM (All)

Steve is discussing with Mark and Kirk Busch subscribing to a CRM/E-mail management service to meet the needs of the AZBSN Task Force.
