## **June 9, 2021**

#### **1.4. Treasurer's Report**

Ron Schott, Treasurer, circulated via email the Desert Financial Credit Union statement with account and transaction details for Board reference, which are included at the back of these Minutes. Ron reported that current funds on hand total \$13,350.27. This balance includes a \$3000 reimbursement as reported last month and another \$5000 reimbursement from GAZEL for Steve Peters' coordination of the AZBSN COVID-19 Digital Access Task Force from sponsorship donations to AZBSN. This completes the full reimbursement of the ATIC \$8000 loan to GAZEL for Steve's coordination of the AZBSN COVID-19 Digital Access Task Force and associated expenses.

Steve is continuing to send out an AZBSN COVID-19 Digital Access Task Force sponsorship package and will be contacting other potential funders.

Mark had noted at a previous Board meeting that we must remember that AZBSN is separate from ATIC. At that time Mark stated there are three potential sources of future ATIC funding: AZBSN sponsorships, ATIC sponsorships, and ATIC grant opportunities. ATIC still needs to work out an MOU before the end of the year with GAZEL about how future AZBSN sponsorship funding will be

shared between ATIC and GAZEL.

Mark said ATIC needs to pursue its own funding, which would include sponsorships. ATIC needs to initiate a financial campaign for sponsors and other sources of funding.

Steve noted in a previous meeting that the AZBSN COVID-19 Digital Access Task Force needs to identify what tasks from the Task Force report recommendations that it will undertake to implement, which would need funding support.

### **1.5. ATIC Board Membership Considerations**

Mark noted that we have an ongoing interest in acquiring more representation from rural communities.

### **1.6. Review of Outstanding Action Items as Documented in April 14, 2021, Minutes**

**ACTION ITEM:** Mark took an action to contact Alan Pruitt Executive Director of the Western Arizona Economic Development District in Yuma as a potential Board Member.

This item remains open for another month.

**ACTION ITEM:** Mark took an action item to work with Jeff Sobotka to identify some rural representatives as potential Board Members. Mark may also talk to Gene Carl of Cox Communications and Toni Broberg of AT&T about Cox and AT&T potential ATIC Board members.

## **3. Activity Reports**

Numerous Board members who normally provide reports to the Board were unable to attend because of conflicts. Mala Muralidharan, Steve Peters and others were attending the Special SHLB Workshop on the FCC Emergency Connectivity Fund. Jeff Sobotka was attending the ACA/NTIA Arizona Broadband Workshop focused on "Tribal Broadband." Consequently, Mark provided summaries of ongoing activities for those topic areas.

### **3.1. Arizona Broadband Strategic Plan & FirstNet (Jeff Sobotka)**

### **3.1.1. Rural Community Outreach**

No report.

### **3.1.2. FirstNet Status & Outlook**

No report.

### **3.1.3. ACA Broadband Strategy & ATIC Role/Support**

Jeff Sobotka, State Broadband Director at the Arizona Commerce Authority (ACA), was unable to attend, as noted above.

Mark reported that ACA has selected the KPMG consulting firm to update the 2018 state broadband strategic plan to focus on middle-mile fiber strategy as well as communities planning for federal grants. KPMG is expected to deliver the results of its work within 13 weeks thus in mid/late September. The focus will be on (1) middle-mile fiber strategy and planning and (2) identifying needy rural communities to serve. The state is currently planning for deployment of middle-mile fiber along I-17, I-19, and I-40 and will be considering other highway routes. This KPMG report will be an addendum to the 2018 state broadband strategic plan document incorporating some substantial new thinking. KPMG is required to hold a number of networking sessions with rural communities, and some AZBSN COVID-19 Digital Access Task Force participants will be invited to attend.

The ACA Arizona Broadband Workshop Webinars being hosted by NTIA that provide guidance on federal grant writing, are continuing. The 1<sup>st</sup> Arizona Broadband Workshop was held on March 3<sup>rd</sup> with about 190 registrants, and the 2<sup>nd</sup> Arizona Broadband Workshop was held on April 7<sup>th</sup>. At the May 5<sup>th</sup> Workshop, the NTIA explained various federal government data sets and other data sources that can be used for broadband planning. At the June 2<sup>nd</sup> Workshop a panel of experts highlighted federal funding programs available to support broadband infrastructure and digital inclusion. There are regional technical assistance sessions following up on each of the Arizona Broadband Workshops. Arizona is the only state NTIA is working with to conduct such workshops in 2021.

## **3.2. Arizona Broadband Stakeholder Network (Steve Peters)**

### **3.2.1. ASBSN COVID-19 Digital Access Task Force Updates**

In previous meetings Steve Peters reported on the AZBSN COVID-19 Digital Access Task Force and noted “digital” includes not only broadband Internet access, but also devices, digital content, professional development, digital literacy and technical support. The Task Force meets every Monday

morning and is now attended by some 50 representatives from broadband service providers, technology companies, state and local government agencies, educational organizations, non-profit organizations and consultants. Steve has noted previously that updates are provided at the weekly task force meetings from the State Broadband Director at the Arizona Commerce Authority (ACA), the Arizona Department of Education (ADE), the Arizona State Library, Telehealth, the Sun Corridor Network (SCN) and the Arizona Corporation Commission (ACC), and there are typically presentations made at the meetings on relevant digital access resources of significance to the task force.

The AZBSN COVID-19 Digital Access Task Force Report and Recommendations was published in November 2020 and is available to be forwarded to appropriate parties. There is a landing page for the Report and one for the Task Force, both of which have been updated. People can download the Report from its landing page at <https://www.arizonatele.org/taskforce-report-2020.html>.

The task force has its own Zoom account and the agenda for the Zoom Monday morning meetings has changed. One hour is not long enough with the increasing number of participants attending, so the length has been increased by fifteen minutes. To reduce the time spent on self-introductions at the beginning, that segment has been replaced by a requirement to register for the meetings with position and contact information and the registration list is then made available to all attendees in the meeting reports. Steve is issuing a weekly task force newsletter and has constructed an Updates & Events webpage on the task force website for important updates relevant to the task force activities. Mark would like to have Steve issue a task force newsletter on significant topics that goes to a broad set of state digital access stakeholders beyond the task force participants.

Mark stated Steve has had difficulty arranging a meeting of the task force planning committee to plan next steps for the task force to follow up on the task force recommendations report. Mark will be discussing with Steve arranging a meeting of the planning committee shortly. There are three potential roles the task force could play: lead new initiatives, support communications and advocacy. The highest priority project right now for the task force is organizing outreach for the new FCC Emergency Broadband Benefit (EBB) program. Another upcoming area of importance is taking advantage of the new FCC Emergency Connectivity Fund (ECF) supporting off-campus connectivity for schools and libraries.

Mark reviewed two ASU projects: Lighting Up the Future and ShapingEDU.

Lighting Up the Future is being led by Lev Gonick, the CIO at ASU, and Dominic Papa at ACA and involves ASU, ACA, The Institute for Digital

Progress, and the SCN. Steve and Mark recently met with them and reported that they are focused on strategy and proof of concept projects. Derek commented that their vision document is meant to facilitate discussions and workshops over the summer to spread awareness. They launched a vision paper which has the same goal of addressing the digital divide in Arizona as our AZBSN COVID-19 Digital Access Task Force Report. At our previous meeting Henry had expressed a sense of confusion about how their mission to address the digital divide in Arizona intersects with and possibly overlaps the recommendations of our AZBSN COVID-19 Digital Access Task Force. Henry was concerned that others such as legislators and rural community officials would be confused about who is recommending what and what are they recommending.

They held a kickoff webinar on May 18<sup>th</sup> to be followed by three roundtable discussions on “The Availability Gap” (already held), “The Adoption Gap”, and “The Utilization Gap”. Mark said they will be hiring a grant writer to apply for funds for small broadband projects, such as lighting up a Citizens Broadband Radio Service (CBRS) network in a trailer park near an elementary school and likely more expansive initiatives going forward. They are doing Proofs of Concept (POCs) that they hope will scale up to larger projects. Mark added that they will probably also do some planning or policy work.

The ASU ShapingEDU “Connecting for Work and Learning: Universal Broadband Access” initiative aims to make concrete collective progress toward a future where broadband is accessible to all. ShapingEDU is part of a national universal broadband initiative that seeks to address this urgent challenge through action-oriented resources, community engagement, and stakeholder inclusion and partnerships. They are a broadband think tank group that meets weekly. Mark and Steve have given them a presentation. They probably won’t be as critical to us as Lighting Up the Future. ### **3.2.2. Marketing the AZBSN COVID-19 Digital Access Task Force Report**

Another ongoing need is to develop a publicity and marketing campaign for distributing the report to all the relevant organizations. A marketing/planning committee needs to be created to plan and execute such a campaign, and the existing database of Arizona economic development leaders and decision-makers needs to be cleaned up and expanded.

### **3.2.3. Return to Outreach Activities with Newsletters & Webinars**

Mark mentioned at previous meetings that he would like to return to public events and engage a broader community. He reiterated that he would like to

have a better newsletter and maybe sponsor some webinars. He acknowledged there is some confusion with what Steve has been referring to as a newsletter, which is technology oriented. Mark expressed his desire to have a newsletter with a broader focus on webinars and customers.

### **3.3. Greater Arizona Educational Leadership (Steve Peters, Nan Williams)**

#### **3.3.1. Arizona Technology in Education Association (AzTEA)**

Nan Williams serves on the EDTech Committee for the Arizona Department of Education (ADE) which is rewriting the Educational Technology standards this year. She is also participating in the ADE Technology Task Force on the Digital Learning Subcommittee, and she is part of the ISTE policy group on digital equity access. She has also been working with the Rural Schools Association and their Final Mile Project (<https://www.finalmileproject.com/>).

Nan reported that most summertime activities are focused on a “take care of yourself” media campaign with healthcare tips. It’s a recognition that everyone needs a little down time. The AzTEA Fall Conference is scheduled for October 23 from 8 am-3 pm and will include working sessions on Twitter and social media.

#### **3.3.2. Labster Virtual Laboratory Simulations Consortium**

There was no report, but as noted in recent reports, the AZBSN Task Force recommends that a virtual laboratories consortium for the state be explored, but not necessarily be limited to Labster technology.

Mala noted at our previous meeting that the lab-science component of virtual education has been brought up frequently, so we need to re-ignite the Labster-like initiatives that were being discussed earlier.

#### **3.3.3. GAZEL Innovative Learning Collaborative Initiatives**

There was no report, but Steve has noted previously that GAZEL needs to be reinvigorated. The GAZEL Board needs to reconstitute itself and purchase D&O insurance.

Steve intends to call a GAZEL Board meeting to discuss future plans shortly. The AZBSN task force has been the main focus of GAZEL in the past year. GAZEL is a 501(c)(3) and so can more easily attract funding from sponsors.



Work is still going on to produce a Memorandum of Understanding (MOU) involving GAZEL, ATIC and AZBSN.

### **3.4. Arizona State Library (Holly Henley, Mala Muralidharan)**

Holly Henley reported at an earlier meeting that the Arizona State Library received \$3.6 million from IMLS under the federal American Rescue Plan Act stimulus funding to help communities respond to the pandemic and support digital equity. This \$3.6 million must be spent by September 2022, and the Arizona State Library will be putting plans together on how to spend this funding among the 90 library systems in Arizona. Mala has been mostly focused on the FCC Emergency Broadband Benefit and Emergency Connectivity Fund programs.

The American Rescue Plan has provided \$3.2 billion for a new FCC Emergency Broadband Benefit (EBB) program to provide discounts for low-income households to purchase Internet services as well as discounts on purchases of computers. This EBB program is in addition to the existing FCC Lifeline program for low-income households, for which 75% of the households eligible have not applied.

In Mala's absence here is some relevant information provided by her to the AZBSN COVID-19 Digital Access Task Force meeting on June 7<sup>th</sup>.

"There was a huge interest in the EBB program. Initially there were a lot of requests and now the requests have significantly declined and a lot of applicants were Lifeline applicants. It could be that the paper applications (possible new adoptions) may not have been fully processed yet. [www.Connect-Arizona.com](http://www.Connect-Arizona.com)'s EBB page got over 2200 hits so far and the navigators received over 1000 calls so far.

"Some of you asked about tracking EBB applications. Here is what I found - a tracker from USAC <https://www.usac.org/about/emergency-broadband-benefit-program/emergency-broadband-benefit-program-enrollments-and-claims-tracker/> **Almost 82,000 Arizonans have signed up**..... we are **8th** highest number of Applicants. Only **California**, Florida, Georgia, N.Y., Ohio, Pennsylvania, Texas have more applications than AZ!"

The AZBSN task force EBB outreach team is led by Tracey Beal (School Connect), Ilana Lowery (Common Sense Media), Cindy Hogan (United Way of Tucson & Southern Arizona), Nicole Umayam (Arizona State Library) and Mala. The Arizona State Library Connect-Arizona website contains detailed information on the EBB program and provides navigators to assist households in enrolling.

The ECF is a \$7.1 billion program created by the American Rescue Plan Act of

2021. It is governed by the FCC and administered by the Universal Service Administrative Company (USAC). Millions of library patrons and students depend on public libraries and schools for their internet access. But when libraries and schools closed their buildings to the public because of the COVID-19 pandemic, many library patrons and students lost internet access because they lacked access at home. From the school perspective this lack of home connectivity is often called the “homework gap,” and from the library perspective it is the “connectivity gap.” The primary purpose of the ECF is to help bridge these gaps by providing off-campus broadband Internet connectivity such as to students’ and library patrons’ homes.

The FCC specified the rules for the ECF on May 10th, but some of the rules are still being clarified based on feedback received. The funds will be distributed to eligible schools and libraries for the purchase of telecommunications services and eligible equipment for use by students, school staff, and library patrons at locations other than a school or library – primarily to homes. Following are some key rules specified for the program.

Schools, libraries, consortia of eligible schools/libraries that are eligible for support under the FCC E-rate program are eligible for ECF as are tribal libraries.

ECF will provide support for broadband Internet connectivity to off-campus locations, such as student or library patron homes. Schools and libraries can receive funding for commercially- available broadband service that provides a fixed or mobile broadband connection for off-campus use by students, school staff or library patrons. In limited instances where a school or library can demonstrate that there are no available service options sufficient to support remote learning for its students, school staff, or library patrons, the ECF may support the construction of new networks or the equipment needed for the services. If commercial service is not available, applicants can partner with a commercial provider to extend its services to unconnected students and library patrons.

The following types of equipment purchased for off-campus use by students, school staff, and library patrons who would otherwise lack sufficient connectivity to engage in remote learning are eligible for support: laptops/tablets (not desktop computers), Wi-Fi hotspots, modems, and routers. A library or school cannot receive support for more than one device or Wi-Fi hotspot per student or patron (can’t get a device from a school and a library). CIPA filtering requirements only will be in effect for ECF-supported services that use ECF-supported devices.

There is a list of ineligible services (specified in Mala’s presentation), which are still being clarified.

The first application filing window will be open for 45 days, during which applicants will be able to submit requests for funding for purchases made

between July 1, 2021, and June 30, 2022. This application window will likely open at the end of June or in early July. If demand during this first application filing window does not exceed available funds, the FCC will open a second application filing window to allow schools and libraries to seek funding for eligible equipment and services they previously purchased before May 2021.

The program will reimburse applicants 100% for all eligible products and services with two exceptions: a maximum of \$400 for each laptop/ tablet, and a maximum of \$250 for Wi-Fi hotspots. The FCC and USAC will review all service and equipment costs to ensure they are reasonable before reimbursing them.

Applicants for the ECF program will log into the USAC EPC portal to obtain the applications and apply online. USAC will review the submitted applications.

Students that receive ECF support cannot also receive Emergency Broadband Benefit (EBB) support for the same broadband service or device, but a student could receive broadband service from EBB and a device through the ECF.

Reimbursements will be paid to the schools and libraries (not the students or patrons). Applicants will also have the option to request reimbursement prior to paying for services, in which case the applicant must pay their vendors within 30-days of receiving their ECF reimbursement.

USAC will wait until the filing window is closed and all applications are reviewed before issuing funding. Should demand exceed available funds, applications will be prioritized and processed based on the Category 1 E-rate discount rate associated with a school or library. Rural applicants will receive a 5% “bump” to the discount rate used to calculate the priority of their applications.

### **3.5. Telehealth (Janet Major)**

Janet Major, Associate Director for Telemedicine Outreach, Education & Facilities, Arizona Telemedicine Program Southwest Telehealth Resource Center (<https://telemedicine.arizona.edu/>), who is now the lead for the Telehealth Broadband Action Team (BAT), was unable to attend but she submitted a presentation containing a number of relevant links that are listed below.

Key aspects of the \$1.9 trillion American Rescue Plan Act (ARPA) and a graphic breakdown of the funding components can be examined at <https://www.naco.org/american-rescue-plan-act-funding-breakdown>. Mark noted that Arizona will also be receiving about \$7 billion from ARPA that will be shared by ACA, the state government, and local governments.

HCW HOSTED (<https://hcwhosted.org/>) is a Tucson-based 501(c)(3) nonprofit

dedicated to facilitating community support of healthcare workers and their families during the COVID-19 pandemic and beyond.

The Emergency Broadband Benefit (EBB) program sponsored by the FCC can be examined at <https://www.fcc.gov/broadbandbenefit>.

Connect Arizona (<https://connect-arizona.com/>) is a collaborative digital equity initiative between Common Sense Media, School Connect, and the Arizona State Library, Archives & Public Records. This project is supported by the Arizona State Library, Archives & Public Records, a division of the Secretary of State, with federal funds from the Institute of Museum and Library Services.

The Arizona Economic Recovery Center is a part of Local First Arizona (<https://localfirstaz.com/>) and aims to enable more qualified Arizona cities, towns, counties, tribal communities, and nonprofits to win competitive federal, state, and foundation grants.

The American TeleMedicine Association Annual Conference on Telehealth: Enabling Flexible, Inclusive and Contemporary Care Delivery will be held virtually on every Tuesday and Thursday in June (<https://gotelehealth.org/ata-2021/>).

The 47<sup>th</sup> Annual Arizona Rural Health Conference in Flagstaff will be a hybrid conference on June 15-16, 2021. For details see <https://crh.arizona.edu/calendar/RHC-2021>.

### **3.6. Government Affairs (Mike Keeling, Mark Goldstein)**

Mark reported that the Governor has signed the ADOT bill for relaxed use and lease of fiber along Arizona's state highways. This bill follows up on ADOT's RFI last year for leasing/managing fiber along state highways by providing a detailed legal framework for this. This ties in nicely with the middle-mile fiber strategy of the KPMG consulting work updating the state broadband strategic plan. Multiple Arizona agencies are cooperating to develop a vibrant and robust middle-fiber strategy for the state beginning in fall 2021.

The Governor proposed \$10 million for the Rural Broadband Development Grants (RBDGs) program for the upcoming fiscal year. The Legislature has been considering increasing the RBDGs funding to \$100 million, but there is debate between the Governor and the Legislature on this amount and who should have purview over this. The Legislature is supposed to approve a budget for the upcoming fiscal year by June 30<sup>th</sup>.

Ron Schott noted that the angel investor tax credit is in jeopardy because of some late input. It provides for a \$100,000 investment to qualify for a \$35,000 tax deduction. The Arizona Technology Council recommended this tax credit be

extended for 10 years. Arizona has become an important data center hub because of incentives it offers for investment, such as data center tax credits bills. This is in line with our broadband interests. Kirk Busch commented that Governor Ducey and the Legislature's renewal of the original bill contributed to Amazon's data center investment. Andy Tobin was an important supporter of this legislation.

Mark noted that at the federal level any infrastructure bill will have a broadband component and there may also be various separate Senate and House broadband bills proposed. NTIA has a new \$288 million broadband infrastructure grants program, and the ACA will be endorsing a state project for this program which could be on the order of \$5 million. NTIA also has a new \$1 billion Tribal broadband grants program. The U.S. Treasury Dept. has a new \$10 billion program for infrastructure of all kinds, which could be used for broadband infrastructure.

#### **4. Information and Action Plans**

##### **4.1. ATIC Website & Teleconferencing (All)**

As noted previously by Mark and Steve, the ATIC website is aging a bit. For example, the resources page is out of date. The website needs to be leveraged to publicize the COVID-19 Digital Access Task Force Report recommendations as well as using it for communications and public engagement, such as newsletters.

##### **4.1.1. AZBSN Communications & Newsletter**

Mark at a previous meeting suggested that we should think about how to leverage some of the information sessions from the Monday morning AZBSN-COVID meetings.

There remains a continuing need for volunteers to work  
(1) on regular maintenance of the Weebly ATIC website and
