1.4. Treasurer's Report

Ron Schott, Treasurer reported that current funds on hand as of July 7, 2020 total approximately \$12,134.80 after recent expenses. Ron circulated the Desert Financial Credit Union report with account and transaction details for Board reference, which are included at the back of these Minutes.

Five payments of \$1,000 have been made to Steve Peters for support of the AZBSN prior to February 29, 2020 and an additional \$4,000 has been encumbered for payments of \$800 per month for March through July. ATIC has paid Steve four \$800 payments for March, April, May, and June, and one \$800 payment remains to be paid

Ron reported that the Directors & Officers (D&O) insurance for ATIC has expired. The

current provider is not interested in providing a new policy. Ron is exploring other options.

Ron also said the annual dues for next year for the Arizona Technology Council (AZTC) membership by ATIC is due and amounts to \$400. Membership allows each ATIC member to attend AZTC events at the membership rate.

The Executive Committee indicated its approval to continue the membership for another year.

Without any current monetary sponsors, sustainability remains a concern. One of Steve Peters' primary tasks for ATIC in coordinating the AZBSN is to determinedly seek sponsors, grants, and other sources of revenue going forward. Mark stated he wants to confer with the ATIC Executive Committee on AZBSN funding and other possible ATIC sponsorship funding.

1.5. ATIC Board Membership Considerations

There has been limited activity and nothing new in the last month. The Board currently has 22 members. ATIC continues to need to expand participation with direct State of Arizona representation, as well as a focus on rural and native stakeholder representation, especially from the economic development community, as well as representatives from municipal, county, and higher education CIOs, plus of course stronger broadband industry participation going forward. Mark is engaging several prospects in that regard.

3.1. Arizona Broadband Strategic Plan (Jeff Sobotka)

In Jeff Sobotka's absence, Mark noted that Jeff provides regular updates on his State Broadband Director activities at the weekly AZBSN COVID-19 Digital Access Task Force meetings.

Mark summarized the Governor's Emergency Education Relief (GEER) Fund from which was allocated \$40 million to install fiber optic cable along two highway segments from Sunset Point to Flagstaff (I-17) and from Tucson to Nogales (I-19). There is hope for some more funding to install fiber along I-40. The Governor's proposal for an additional \$10 million in rural broadband development grant funding, managed by ACA, was not included in the "skinny budget" approved by the State legislature, but there may be a special session of the legislation that considers this or other pandemic relief funds that could be allocated for this purpose in the future.

3.2. Arizona Broadband Stakeholder Network (Steve Peters)

3.2.1. AZBSN COVID-19 Digital Access Task Force Updates

Steve Peters reported on the AZBSN COVID-19 Digital Access Task Force. He explained that "digital" includes not only broadband Internet access, but also devices, digital content, professional development, and technical support. The Task Force meets every week and is attended by 35-40 representatives from broadband service providers, various state government agencies, the Arizona Commerce Authority, educational organizations, telehealth organizations, economic development officials, broadband service providers, technology companies, non-profit organizations and consultants. He briefly summarized the meetings that have been held as well as the summary reports produced and distributed following each meeting. Weekly briefings on activities are given by Jeff Sobotka (the State Broadband Director), Mala Muralidharan (Arizona State Library), Sophia Mayberry (Arizona Dept. of Education), Lea Marquez Peterson (Arizona Corporation Commission), and Karen Ziegler (Public Safety Program, ADOA).

Four subcommittees to make recommendations have been created: (1) the Education and Library subcommittee is led by Nan Williams, Executive Director, Arizona Technology In Education Association, and Mala Muralidharan, E-rate Administrator for Public Libraries, Arizona State Library; (2) the Funding and Resources subcommittee is led by Lea Marquez Peterson, Commissioner of the Arizona Corporation Commission; (3) the Technology subcommittee is led by Tom Mehlert, Executive Director of AZ StRUT, and Steve Hill, President of the Satellite

Broadcasting & Communications Association; and (4) the Communities subcommittee, is being led by Alan Pruitt and John Lucas.

Steve is writing/assembling a document that will incorporate the preliminary recommendations from the Education and Libraries, Funding and Resources and Technology subcommittees that is intended to be distributed to policy makers by the end of July.

Nan and Mala reported that the Education and Libraries subcommittee has three major goals: (1) The collection of reliable and useful data for decision-making, such as the availability and location of public Wi-Fi access points. (2) The providing of technical support, including a "Library Tech Helpline Service" which is hiring library staff to provide phone-based tech help support, digital literacy training, and information regarding low-cost home Internet service offers. (3) How to optimize and share resources among agencies and organizations such as the Arizona Department of Education (ADE), the numerous state libraries, the Arizona State Land Department (ASLD) and others.

Nan and Mala said they are planning for a deliverable in the form of a set of recommendations for the overall task force preliminary recommendations document. Mark commented on the recommendation dealing with the Sun Corridor Network, noting that its charter applies to the entire state of Arizona. It should not be confused with the economic entity called the Sun Corridor that focuses on the Flagstaff-Phoenix-Tucson corridor. Nan praised the high level of collaboration that has been present among numerous private and public entities. This has been quite productive in developing the recommendations. Mala agreed that the partnersh[ps and collaboration has been very valuable and led to the discovery of projects that were previously unknown by other groups, such as the Arizona Blockchain Initiative. Steve suggested adding an agenda item to better identify our assets, their accomplishments and how to collaborate among all of them.

The Education and Libraries subcommittee meets via teleconference every Thursday at 9:30 a.m. and all are welcome to attend.

The Technology subcommittee has begun to meet regularly to identify what technologies are available and how they can support the needs for education, libraries, and communities. Steve said the subcommittee intends to look at case studies of mesh networks, satellite broadband and other solution options.

The initial meeting focused on AzSTRUT with a presentation given by Tom Mehlert, its Director. Mark Goldstein gave an excellent presentation on the nature of and outlook for the next generation of wireless broadband technology. Insight gave presentations on the student home LTE router bundle and gateway LTE router that can be mounted on school buses for community access. Other scheduled presentations include satellite broadband solutions by Viasat, mesh networks and other emerging technologies.

The Technology subcommittee meets via teleconference every Tuesday at 9:30 a.m. and all are welcome to attend.

Lea Marquez Peterson leads the Funding and Resources subcommittee which is considering various funding and donation sources and how to help in the grant writing process.

Toward that end Mark Goldstein has put together a valuable extensive list of broadband planning and grant-writing consultants that is posted on the COVID-19 Digital Access Task Force website. The subcommittee also wants to look at the possibility of setting up a fund for organizations and communities to hire consultants to write grant applications,

Mark noted that one of the subcommittee's recommendations is to use eCivis, a grants management system for the state government for grants offered by the federal government, state government and some foundations. Because eCivis is complex to use Mark recommended that someone needs to be empowered to monitor broadband grants of general interest in eCivis and send reports on these to stakeholders as well as execute specific broadband-related grant searches of eCivis on request.

Steve and some task force members met with the Community Reinvestment Act (CRA) policy point person for Arizona to understand the potential for CRA funding to support digital equity projects in Arizona.) The CRA will not directly fund schools but will provide funding to 501(c)(3) organizations, which can work with schools to pay for broadband infrastructure and other significant projects,

Lea, in her role as ACC commissioner, is part of a National Association of Regulatory Utility Commissioners (NARUC) task force that is investigating the possibility of transitioning Universal Service Fund (USF) money from supporting POTs in high-cost rural areas to support broadband development in these areas.

Although Jeff Sobotka, Mala and others are focused on federal and state government funding, it is important to remember that other funding sources are also available. Specifically the subcommittee needs to identify private sector funding sources.

Jeff Sobotka, Mala and Milan Eaton need more people to assist them with grant application work.

The Funding and Resources subcommittee meets via teleconference every Friday at 10:00 a.m. and all are welcome to attend.

Alan Pruitt, Executive Director and Grants Manager for the Western Arizona Economic Development District (WAEDD) in Yuma, and John Lucas lead the Communities subcommittee which will address small businesses, senior citizens and other community needs.

Alan was instrumental in identifying and setting up a meeting with the CRA policy point person for Arizona.

3.2.2. Continuation of Steve Peters' Coordinators Agreement August thru December 2020

Mark recounted what Steve Peters has accomplished as a coordinator for AZBSN dating back to the first successful event at Rio Salado Community College and two subsequent webinars. After the pandemic arrived, ATIC approved paying Steve \$800 per month to manage the AZBSN COVID-19 Digital Access Task Force with the stipulation that this funding be reimbursed to ATIC as its first priority when AZBSN receives sponsorship/grant funding. Mark moved to extend this agreement from August to December 2020 at \$800 per month since AZBSN has not yet received any funding.

MOTION: To pay Steve Peters a monthly fee of \$800 for his role as AZBSN Coordinator for August 1 to December 31,2020. The total \$8000 ATIC funding of Steve Peters for managing the AZBSN from March to December 2020) is to be reimbursed to ATIC as first priority when AZBSN receives funding support.

MOVE Mark Goldstein SECOND: Bob Jacobson Passed Unanimously

Ron asked what is being done about fund raising for ATIC. Mark replied that there are three avenues that need to be explored.

One is related to the pandemic response, such as the Arizona Together grants, the AZ CARES Grant and others to be investigated by Bob Jacobson, Bob stated he would like to pursue state policy funding for ATIC rather than intermittent funding

The second avenue is the more traditional seeking of sponsorships and donations.

The third is the initiation of an AZBSN funding drive by Steve Peters.

3.4. Arizona State Library (Holly Henley, Mala Muralidharan)

Mala and Holly reported they are involved in assisting the Navajo Nation to qualify the 49 chapter houses as branch libraries of the Navajo main library in Window Rock for E-rate funding, so they are trying to help them to get people trained. The tribe already has the computers and are waiting for the connectivity. Previous BTOP funding to the Navajo Nation enabled fiber to POPs, and E-rate grants would be used for the last mile to the chapter houses. Mark noted that several Satellite Cell on Light Trucks (SatCOLTs) have been set up by AT&T on the Navajo Nation as part of the FirstNet deployment.

Nicole Umayam is doing a pilot help desk project to prioritize the hiring of personnel who have been laid off. Holly Henley noted the CARES Express and Expanded Grants programs have been completed, and they opened up application for the CARES Supplemental grants (e.g. for virtual tours of museums). The Governor issued on July 1st an executive order to continue operation of the Arizona State Library until March 2021.

The State Library Report for the July 8th ATIC Meeting

Holly Henley, State Librarian:

1. State Library Continuation

- a. On July 1, Governor Ducey issued an Executive Order that continues the State Library until March 31, 2021 or until action is taken by the legislature for continuation or termination. Due to COVID-19, the Arizona legislature had adjourned in May before the final vote on the bill to continue the State Library under the Sunset Review process.
- b. Specifically mentioned in the Executive Order is the fact that the State Library has CARES Act funding to distribute to libraries. Letters from Secretary Hobbs, legislators, and community stakeholders are also called out. We are very grateful for the opportunity to continue fulfilling our mission of "Preserving Arizona, Providing Access."

2. CARES Act Supplemental

- a. The State Library received \$657,394 in CARES Act funding from IMLS to help "prevent, prepare for, and respond to coronavirus, including to expand digital network access, purchase internet accessible devices, and provide technical support services." State Library staff developed three funding opportunities to support Arizona residents through their libraries: CARES Express, CARES Expanded and CARES Supplemental. Visit https://azlibrary.gov/libdev/funding to learn more about the first two phases, which have had funding allocations made already.
- b. <u>CARES Supplemental</u>, the third phrase, focuses on library partnerships with museums and workforce development organizations. Libraries of all types are invited to apply for grants of up to \$10,000 to respond to the coronavirus pandemic. Successful CARES Supplemental projects will address problems of digital access created or exacerbated by the COVID-19 public health emergency.

3. Online Summer Reading

- a. The State Library has been providing a summer reading program for many years. An online version was added six years ago as an option, but with the pandemic and library closures, is being much more widely used this summer.
- b. In 2014 Maricopa County Library District developed and piloted, with the support of an LSTA grant from the Arizona State Library, an <u>online summer reading program</u>. The Great Reading Adventure is a web-based, open-source software program designed to manage reading programs in schools and libraries. Maricopa County Library District has continued to provide the program to all public libraries within Maricopa County with new features added every year.
- c. For the 14 other Arizona counties, the Arizona State Library provides online software to support virtual participation by patrons of all ages in reading programs. <u>READsquared</u> allows libraries to custom tailor the patron experience with targeted features, functions, and content by age. Kids can earn badges, complete online activity missions, and play games. Young readers can also write book reviews, find lists of cool books, and make wish lists of books they want to read.

4. Library Tech Helpline Pilot project

he Library Tech Helpline is a temporary phone-based tech support service of Helpline Specialists providing basic tech support, sign-up information for home internet service, guidance on online learning resources, and device advice to Arizonans. The Helpline will be piloted by the Arizona State Library from approximately June 29 – September 30, 2020.

- 5. Diversit-E Digital Content for Public Libraries
 - a. During the pandemic, Arizona library staff have continued to meet the needs of their communities with new service models, and the State Library has reallocated resources to support their work accordingly. One of those ways has been to enhance digital services. As it continues to be challenging to provide in-person services, the State Library is offering an opportunity for public libraries to provide additional ebooks and e-audiobooks for customers by directly paying libraries' current vendors for e-content. This project is called Diversit-E.
 - b. Participating libraries will receive funding in their ebook accounts to select titles relating to equity, diversity, inclusion and social justice. Selections may be for any age group, and multiple copies of the same title may be purchased. Formats must be either ebook or e-audiobook.
 - c. The State Library also provides free content on <u>Reading Arizona</u> on these timely topics. <u>Arizona Voices</u> is a collection of over 70 titles related to the racial equity and social justice struggles faced by various populations throughout Arizona's history.

- 6. E-rate update
 - a. The Navajo Nation on behalf of 49 Chapter Houses as Branches of the Window Rock Main Library Navajo Nation has applied for E-rate funding to connect the Chapter Houses (last mile) to the Fiber network that NTUA had laid as a part of the BTOP grant funding in 2009. The State Library is working with the Nation to help them understand the requirements for eligibility to receive the funding.
 - b. The Universal Service Administrative Company (USAC) is adding multifactor authentication (MFA) to the systems to increase the security of Universal Service Fund (USF) IT applications. It will require the user to enter two or more separate pieces of information, such as a password known to the user and a code USAC generates and sends to the user in order to gain access. Starting July 27, EPC users and BEAR Form filers must first log in to One Portal (our MFA security system) to access these applications. On July 27, after MFA has been deployed and new user accounts created, we will send a second email with instructions on how to log in and how to set up their second verification factor.
 - c. USAC, in coming weeks, the Schools and Libraries (E-rate) Program and Lifeline Program have scheduled Virtual E-rate Information Series for Tribal Applicants stakeholders.

The Lifeline Program is one of the four federal benefit programs administered by the Universal Service Administrative Company (USAC). Lifeline helps households obtain affordable connectivity services by providing a discount to low-income consumers. Lifeline subscribers may receive up to \$9.25 off their monthly phone or internet bill and Lifeline subscribers that live on federally recognized Tribal lands may receive up to \$34.25 off their monthly bill. Consumers qualify for Lifeline through participation in government programs (such as SNAP or Tribal TANF) or if their income is at or below 135% of the federal poverty guidelines. 3.5 Telehealth (Janet Major)

Janet Major gave a brief report on the recent Arizona Telehealth Broadband Action Team (BAT) monthly meeting held on June 7. At that meeting Jeff Sobotka reviewed several BATs that he has helped to set up in communities across Arizona. He noted that the Telehealth BAT is statewide and is focused on the needs of telehealth providers and patients. The goal of this BAT is to provide collaboration and potential ideas on how to improve broadband access for telehealth in the state. This was followed by a group discussion regarding Navajo Nation broadband infrastructure challenges, issues and funding.

Janet expressed her desire to see a Four Corners BAT established for the entire Navajo nation to increase the level of cooperation to consider education, library and telehealth uses of chapter houses which could open up more grant opportunities. More people who have a stake in the Navajo Nation need to be included. The Nevada broadband specialist, Jojo Meyers, has done a similar project to link up the chapter houses with the libraries and as a result has been successfully awarded USDA-DLT and other grants.

The BAT meeting also included a review by Jeff on available federal and state broadband grant opportunities, including the

3.6 Government Affairs (Bob Jacobson, Mark Goldstein)

Mark provided the following updates on federal legislative activity.

7/8/20 The House Appropriations Subcommittee on Financial Services and General Government approved its fiscal year 2021 funding bill by voice vote on July 8, 2020. For fiscal year 2021, the draft bill includes \$24.64 billion in discretionary funding, an increase of \$808 million over the 2020 enacted level. The bill includes \$376.1 million for the FCC, an increase of \$37.1 million above the FY 2020 enacted level that includes funding to implement new broadband mapping legislation. Additionally, the bill includes \$61 billion in emergency funding for the FCC to expand availability of broadband to unserved areas, as well as multiyear funding for broadband mapping and replacement of telecommunications equipment deemed to pose a national security threat to the United States. 7/6/20 **Broadband Adoption and Opportunity Act** was introduced by AZ Rep O'Halleran: https://ohalleran.house.gov/newsroom/press-releases/ohalleran-introduces-legislation-connect-students-and-families-computers

7/3/20 House Democrats have now passed the **Accessible**, **Affordable Internet for All Act**, broadband legislation which is included in the <u>Moving Forward Act</u> and proposes \$100B for broadband initiatives. Senate Democrats introduced matching legislation. Also, there has been bipartisan Senate introduction of the **Rural Broadband Acceleration Act**(https://www.portman.senate.gov/newsroom/press-releases/portman-brown-braun-bennet-jones-upton-clyburn-introduce-bipartisan) with new broadband funding included. So, encouraging movement on new funding, but no telling where it will go short term. Believe it bodes well for new broadband infrastructure funding later this year or early next year.
