They're doing, they're actually collecting data as part of these community events. So they are and they have limited space in the halls and the rooms that they're that they're getting for these events.

We've talked about the governor's funding success and just to recap, there was an approved 23.6 million of an initially requested by the governor 50 million for a brand new funded commerce that can be used by communities or other potential bead applicants as part of their matching.

Remember for B, 25% matching will be required in a minimum. So, the state will have some matching funds to play with through commerce and the other element was, e-rate leverage.

I believe that was 5 million Mollock and correct it if that's wrong, but like several years ago when we had 11 million, there's interesting ways in cooperation with the FCC to leverage it.

The one I don't know about is what happened to the, there was a railroad crossing bill, but there was also a more general.

One of those is American County Transportation Tax. There's some other bills out there so but meanwhile they're just taking a little brick So it's kinda weird, they're not adjourning, they're not going away, but they're not.

Well, there was a bill, that was being run by a representative Matt Grass, the Governor Deuces former budget director to only state devices as well as contractors to the state.

There were some. You're gonna minute work that took place. The bill, the amendments were added.

Thank you. Right, it was at a contract or a KPMG or an Accenture would have to similarly ban TikTok in their organizations.

You've had overly broad language, which got, scaled back significantly the universities had at a role in some of those amendments as well, but the governor did sign an executive order banning TikTok or what applications.

From state. Use and that is the policies and procedures being put in place for that as we speak.

We are not Montana, which did pass the bill, the band to talk for everybody. So.

ECF funding was funding that was given to schools and to libraries. For hotspots and devices that they could loan out to their students as well as to the patrons.

And that was again a pandemic response. And it was said to, it is now set to sunset June thirtieth, 2024.

They did have service delivery. Deadline was extended that was the service delivery Deadline was December 30 first December.

Yeah December 2023 but they've extended it to June thirtieth of 2024 that as well because of delays in receiving.

Goods that had been ordered. But having said that, that is the demand is still there. There's a high demand, higher demand, especially with school kids.

You know those who are graduating out of the program some of them are returning their equipment others are not there's a lot of equipment coming back that is damaged and needs to be replaced.

Federal announcement or the federal end of the public health emergency. That was May eleventh.

So those are 2 things that are still kind of ongoing. We're just using that information and kind of lead into next full year.

They get tools, resources, links to material. That we have put together for them that includes even policies and procedures like templates that they can just copy and paste and procedures like templates that they can just copy and paste and utilize for, the development of their own.

Policies and procedures. It includes, disaster recovery planning and assessment of the readiness for, for DRP preparation plus some resources to get started.

That I wanted the flyer to be able to present that so we haven't had all that information ready to go yet.

So we are still on a Hold. For confirmation from. The governor's office but but I'm confident that you know support for cybersecurity will continue in one shape or another.

So we're districts taking advantage of that program.

[Karina Jones] 15:46:53

Yeah, right now it was over 120 something, Philip. That enrolled and, but we have hold, we have put on hold, featuring, for now.

Yeah, thank you, Karina and Phillip. I was on the call, a call last week with the folks at Just UN unified was a victim of a very significant ransomware attack.

[John Kelly] 15:47:18

That had substantial impacts on their operations for a period of time. I wanted to convey to the group that both the, the Department of Homeland Security, and the school trust, which is insurance coverage and, ODTL provided enormous amounts of support.

[John Kelly] 15:47:37

To Tucson Unified. There are a lot of really tremendous lessons learned from that experience. A lot of things the district should have done in advance that they didn't do.

[John Kelly] 15:47:47

A lot of things they have done that prevented it from being much, worse, but there was some significant practical issues related to where some secure data had been stored on personal hard drives where it shouldn't have been.

[John Kelly] 15:48:01

So there's a lot to learn from this, but I just want to convey to this group that there was some a lot more, I think, resource available to, Tucson Unified.

[John Kelly] 15:48:11

As a result of some of the work that's been taking place over the last couple of years than there would have been 2 years ago it never feels as if we're making progress.

I just wanted to recognize it. I think there are still some questions about. How that grant program is gonna work because it does fund tools for a period of time.

Yeah.

Some school districts are prepared to utilize those tools. Some are already paying for tools and not utilizing what they're already paying for.

There are some system things that have to be improved, but overall I just think they're Carina and Ryan Murray and Philip and others need some credit for the work that they're going.

Monitor. For local education agency sexual. Implementation of. Solutions, let alone what solution to implement.

But if we can give them the resources to do their own assessments and evaluations, that is, that is what this, capacity assessment is packed with, disaster recovery, disaster preparation.

Planning. And yeah, so if you can keep spreading the word and have people fill out that assessment that will help them and will help us all.

With the data to continue to help them.
