# Task Force Sponsors, Events & Updates Webpage, Participants List, Kibitzing with Colleagues, Task Force Design Team Meeting

### Task Force Sponsors

Steve Peters again thanked Care1st Health Plan Arizona, Valley of the Sun United Way, the Satellite Broadcasting & Communications Association, and Kajeet for providing sponsorship funding for this task force. The sponsors are displayed on the task force website.

Steve is continuing to seek further funding support for the task force's upcoming work, and welcomes any organizations interested in becoming sponsors. He posted a link on the task force website on how organizations can become a sponsor.

### Task Force Events and Updates Webpage

Steve continues to add information relevant to the task force on the Events and Updates webpage of the task force website. Steve includes a link to this webpage/newsletter in his emails to the task force, and strongly encourages task force participants look at this webpage regularly for important information on programs (e.g. federal/state grant programs), events, and contacts. Steve regularly updates this webpage with new announcements and activities of interest to the task force.

#### Task Force Participants List

Steve noted that the task force participants spreadsheet is located on the task force website. Steve again asked attendees to fill out the Google form on the website to be included in this spreadsheet. This is a good place for task force participants who are looking to connect with others on the task force.

Attendees at task force meetings showing their position and contact information are also included in an Appendix of each task force meeting report.

<u>"Kibitzing with Colleagues" Sessions</u> Steve stated again that there are "Kibitzing with Colleagues" sessions held immediately after the Monday morning task force meetings, where task force participants can informally talk, share, or collaborate on any topics of interest. There is no agenda, no presentations, and no specified ending time for these sessions.

#### Task Force Design Team Meeting

Steve reviewed the results of the task force design team meeting held on November 18th to identify priorities and strategies for task force activities in 2022.

Steve stated there are multiple possible roles for our task force: a lead organization. collaborating with other organizations, supporting communications, advocacy, and fundraising. Mark Goldstein, Chair of the Arizona Telecommunications & Information Council (ATIC), noted that ATIC has in the past executed projects.

Following are the main points that were discussed at the task force design team meeting.

- The task force should become more action/task oriented. This may involve creating task teams/subcommittees as the task force had in 2020 to write its digital access strategy report.
- There should be events/strategies to facilitate networking, collaboration, partnering, and problem solving.
- Continue discussion with Jeff Sobotka (State Broadband Director) and his new Assistant Broadband Director at the Arizona Commerce Authority about how to collaborate.
- Consider how to work with the ASU "Lighting Up the Future" Project.
- Coordinate with the Arizona Dept. of Education on resulting activities from their Technology Task Force.
- Task Force Monday meetings could be restructured to only do updates every other • week, except for continuing weekly updates from Jeff Sobotka or reporting any important breaking news. This would leave more time for sharing/discussion among task force participants.
- The task force Digital Inclusion Team work including the Connect-Arizona website Digital • Inclusion Directory will be a significant priority.
- Meet with Lea Marguez Peterson, Chair of the Arizona Corporation Commission (ACC), to further discuss ACC Arizona Universal Service Fund reform recommendations.
- The Digital Equity Act of 2021 requires the development of a State Digital Equity Plan, • and the task force should consider who will lead this.
- Coordinate and share information about community broadband initiatives around the state.
- Advocate for and coordinate the development of a Sun Corridor Network strategic plan.
- Advocate for and coordinate support for expansion of the ADE "Final Mile Project".

Shereka Jackson asked about whether cybersecurity will be addressed, and Steve replied that the design team did not discuss that yet but he is proposing that it be part of the task force digital inclusion work since there are a number of organizations around the state addressing it.

Lindsay Dietz, Director of Program Service for the Arizona Alliance of Community Health Centers, stated she would like to be involved in discussions of the task force design team or maybe they could bring in people as needed on specific topics. Steve responded that the intent was to keep the task force design team relatively small so that they could outline directions for

the task force next year. Kirk Busch added that this is like an AZBSN Task Force 2.0, where the task force impacts effectively what the participants would like to achieve. Marcelino Flores, Special Staff of Pima County, commented about their "Devices First Initiative" as important for digital equity, and that it is important to consider workforce training for businesses to learn how to use cloud services (e.g. Amazon AWS). Steve responded that business community needs should be addressed, and may be addressed as part of a Technology team (the task force had such a team in 2020). Mauricio Orozco added that the task force could involve local Chambers of Commerce.

Steve concluded by saying that task force participants can send him any suggestions to bring to the task force design team. Steve will report results from the next task force design team meeting to the overall task force.

# Updates: State Broadband Director, AZ State Library, ADE, ACC, Sun Corridor Network

#### State Broadband Director Update

Jeff Sobotka, State Broadband Director at the Arizona Commerce Authority (ACA), reported on his recent activities.

As reported at the last task force meeting, the ACA Arizona Broadband Development Grant Program launched on November 15th and information about it has been posted on the ACA website (www.azcommerce.com/broadband). The Arizona Broadband Development Grant Program (ABDG) provides \$100 million to expand high-speed broadband infrastructure to underserved areas of the state: \$75 million will be targeted to rural counties and \$25 million will be targeted to the urban counties (Maricopa and Pima counties). The deadline for applications (originally December 10, 2021), has been moved out to be January 31, 2022. Jeff stated that grant awards are expected to be announced by the end of February 2022. Jeff noted that Teri Orman, ACA Grants Manager/Administrator, will collect all questions about ABDG and post the answers on the website (Jeff posted Teri's e-mail address in the Appendix 1 Chat). Jeff stated that he heard about a number of proposed projects, and there are several RFPs out where communities should have selected service provider partners. They are encouraging ABDG applications for this once-in-a-generation opportunity, and will post them publicly.

The federal Infrastructure Investment and Jobs Act was passed on November 5th. It will drive unprecedented investment in broadband infrastructure, and has funding allocated in a number of different buckets. Jeff noted that Arizona will receive a state block grant for broadband infrastructure, and will also want to maximize its share of the entire broadband/digital equity funding available under this Infrastructure Bill.

As reported at previous task force meetings, ACA engaged KPMG at the beginning of the summer to do an update of the 2018 state broadband strategic plan. Jeff stated that the KPMG report will be released soon, and it is primarily focused on middle-mile strategy for the state.

#### Arizona State Library Update

In the absence of Mala Muralidharan, E-rate Administrator for Public Libraries at the Arizona State Library, Holly Henley, State Librarian, and Nicole Umayam, Digital Inclusion Library Consultant at the Arizona State Library, reported on Arizona State Library recent activities.

Holly stated that she, Jaime Ball, and Mala had a conversation about the telemedicine in libraries pilot projects at two libraries in Pima County (as reported on by Mala at the last task force meeting).

Nicole reported that the Arizona State Library Connect-Arizona website digital navigators have supported 1500 calls to date with an average call length of 22 minutes. About 1/3 of the callers are repeat callers who find this service useful. About 8% of the calls have been about Internet service offers, and there were 75 calls about the Emergency Broadband Benefit (EBB) program (which has been complicated to understand in some cases).

The FCC held a roundtable for libraries and other community anchor institutions on the EBB program to share challenges on getting households enrolled. The EBB program will be transitioned to the longer-term Affordable Connectivity Program (as discussed by Mala at the last task force meeting) after December 31, 2021. There will be a 60-day transition period after December 31st for EBB-enrolled households to receive their current monthly benefit. The Connect-Arizona website will contain information about the new Affordable Connectivity Program. Steve Peters asked about the Lifeline program, and Nicole replied that the Lifeline program will continue operating.

There are two Library Services & Technology Act (LSTA) express grant programs that have been posted: one for Wi-Fi expansions in libraries, and the other for libraries' Wi-Fi hotspots lending.

Nicole noted that the task force Digital Inclusion Team will hold meetings twice a month (1st and 3rd Thursdays of each month). The Connect-Arizona website will host the Arizona Digital Inclusion Directory (discussed at previous task force meetings) to provide information about organizations doing digital inclusion work in the state and encourage collaboration.

#### ADE Update

Sophia Mayberry, Project Manager and Technology Policy Coordinator in the Office of the Superintendent of Public Instruction at the Arizona Dept. of Education (ADE), reported on recent ADE activities.

Sophia reported that the new ADE Office of Digital Teaching and Learning, on which Chris Richardson (Acting CIO of ADE) delivered a presentation to our task force on October 4th, launched last week its survey of schools to assess their needs and biggest challenges. This assessment survey will guide the planning of this new ADE office.

Steve Peters asked if the ADE Technology Task Force is still operating, and Sophia replied that this task force operated for about a year from June/July 2020 – July 2021 and is no longer operating.

Mark Goldstein asked about the replacement of Chris Richardson, who has been acting CIO of ADE. Sophia responded that there is a job posting for this position (see Sophia's link in the Appendix 1 Chat to this job posting).

#### ACC Update

Lea Marquez Peterson, Commissioner and Chair of the Arizona Corporation Commission (ACC), reported on her and recent ACC activities.

Lea explained that the ACC regulates the utility industry, and has some limited jurisdiction over telecommunications service providers.

Lea participates in the National Association of Regulatory Utility Commissioners (NARUC) Broadband Expansion Task Force. Cox Communications presented at a recent NARUC meeting on their discounted Internet service offerings: Connect2Compete (for low-income families with K-12 children) and the new ConnectAssist (for low-income households). Lea asked task force participants who do outreach on discounted Internet service offerings to make their clients aware of these Cox services. NARUC discusses various states' broadband initiatives by their commissions, and Lea is exploring potential new ACC initiatives based on these which she would like to discuss with our task force.

Lea noted that the ACC's Arizona Universal Service Fund (AUSF) reform to support broadband in high-cost rural areas is still with their legal division. Lea invites discussion with our task force on how the AUSF could be reformed, as was begun earlier this year by the task force.

Lea thanked Sophia Mayberry and the ADE Superintendent of Public Instruction for a meeting she had with them on what the ACC could do to help education.

#### Sun Corridor Network Update

Derek Masseth, Executive Director of the Sun Corridor Network (SCN), reported on recent SCN activities.

The middle-mile fiber deployment on I-17 Segment 1 (from 34 miles south of Flagstaff down to McGuireville rest stop) broke ground in October, and Segments 2 and 3 on I-17 (McGuireville to Phoenix) will break ground in early 2022. The winner of the RFP for middle-mile fiber deployment along I-19 from Tucson to Nogales will be awarded in January. Construction is targeted to be completed for I-17 and I-19 middle-mile fiber deployment by December 2022.

SCN is continuing work on addressing the digital divide in the Isaac School District in Phoenix and the City of Page (as discussed at previous task force meetings).

SCN is continuing to advance the Eduroam footprint to school districts across the state.

# Federal Infrastructure Investment and Jobs Act Including Digital Equity Act of 2021Presentation

Cindy Hogan, Digital Inclusion Ambassador and with Literacy Connects in Tucson, delivered an overview presentation on the recently-passed federal Infrastructure Investment and Jobs Act (IIJA), and the Digital Equity Act of 2021, which is part of the IIJA. Following is a summary of key points from the presentation, and the full presentation and meeting recording will be posted on the task force website.

The IIJA provides \$65 billion overall to states, community organizations, and other entities for a range of broadband deployment and digital inclusion activities.

#### <u>BEAD</u>

IIJA provides \$42.45 billion for the Broadband Equity, Access, and Deployment program (BEAD). BEAD will award states formula-based grants (a minimum of \$100 million per state) for broadband infrastructure, mapping, and adoption projects. NTIA will administer this program,

and has 180 days to establish the rules for the program. States will be required to submit a 5yer action plan, which must be informed by collaboration with local/regional entities. BEAD will support broadband infrastructure for unserved areas (that lack 25/3 Mbps access) and underserved areas (that lack 100/20 Mbps access), with 100/20 Mbps the minimum required speed of service. It will also: provide funding to connect eligible community anchor institutions (a third priority); fund broadband mapping; and broadband adoption projects such as providing affordable Internet-capable devices. States may use no more than 5% of their funding for planning and pre-deployment activities.

#### Affordable Connectivity Program

IIJA provides \$14.2 billion for the Affordable Connectivity Program, which makes the Emergency Broadband Benefit (EBB) program into a long-term program, but still not yet a permanent program. The Affordable Connectivity Program has a reduced subsidy from the EBB program, \$30 per month instead of the previous \$50 per month, but leaves the EBB tribal subsidy the same. It requires the display of consumer labels on broadband service plans, and requires the FCC to adopt rules regarding digital discrimination.

Mark Goldstein commented that the U.S. Dept. of the Treasury Coronavirus Capital Projects Fund and BEAD both require broadband infrastructure provider applicants to meet new affordability requirements, where they must describe what the pricing of the associated broadband service would be and this pricing must be at or below benchmark pricing for their region. Cindy Hogan added that Affordable Connectivity Program subsidies will apply to all broadband services offered by a service provider.

#### Digital Equity Act of 2021

The IIJA's Digital Equity Act of 2021 (DEA) appropriates \$2.75 billion to be distributed through two grant programs: the State Digital Equity Capacity Grant Program and the Digital Equity Competitive Grant Program. These funds can be used for a variety of digital inclusion efforts, including but not limited to device distribution programs, digital literacy training, and digital navigation assistance.

The State Digital Equity Capacity Grant Program is broken into planning and capacity grants. The DEA appropriates \$60 million for planning grants, which are to be awarded to states to develop required state digital equity plans. The DEA allocates \$1.44 billion over five years for capacity grants to implement their state digital equity plans (digital inclusion priorities, strategies, and initiatives).

The Digital Equity Competitive Grant Program appropriates \$1.25 billion over five years for grants to eligible entities, including but not limited to local governments, non-profit organizations, and community anchor institutions. This funding will not come through the states, but rather through the Dept. of Commerce.

The DEA funds can be used for eligible populations to: facilitate broadband adoption to support education and employment opportunities; implement training programs; make broadband equipment and software available at little or no cost; and construct/upgrade public-access computer centers at community anchor institutions.

The Dept. of Commerce NTIA will award the DEA grants, and no more than 90% of project costs can come through a grant.

Nicole Umayam, Digital Inclusion Library Consultant at the Arizona State Library, noted that the state-designated entity administering the State Digital Equity Plan must collaborate with

appropriate state stakeholders. NTIA will release the Notice of Funding Opportunity (NOFO) for the DEA within 180 days, and states must submit an application to NTIA not later than 60 days after NTIA has published the NOFO (Nicole indicated they have a year to submit the application, which is different than the Benton Institute analysis of the DEA).

#### Other IIJA Programs

IJA funds several other programs: \$2 billion for the USDA Rural Utilities Service ReConnect program: \$2 billion for the existing NTIA Tribal Broadband Connectivity Program; \$1 billion for new Middle-Mile projects program under NTIA; and \$0.6 billion for Private Activity Bonds for broadband deployment.

Mark Goldstein commented the Tribal Broadband Connectivity Program funds will be available soon because it is an expansion of an existing program, whereas the new BEAD and DEA programs may not be available until 3Q 2022 because the rules of the programs must be created.

## **Next Steps**

The next AZBSN COVID-19 Digital Access Task Force overall meeting will be held on Monday, November 29th at 7:30 am.

Steve Peters discussed the schedule of task force meetings through the end of 2021. There will be task force meetings every Monday except for December 27th. Karen Ziegler suggested that the December 20th meeting be a networking/kibitzing meeting rather than a typical meeting.

Cindy Hogan and Steve Peters announced that Wes Brownfield, Executive Director of the Arizona Rural Schools Association, who is a participant in our task force, was highlighted in a recent Tucson newspaper article about broadband, and was quoted in the Governor's announcement of the new Arizona Broadband Development Grant Program.

Mark Goldstein announced that he was recently interviewed y an NPR/PBS reporter in Tucson about the Arizona Broadband Development Grant Program and relevant service providers in southern Arizona.

Henry Goldberg and Oris Friesen will write up a summary report of today's task force meeting.
