Task Force Sponsors

Steve is continuing to seek further funding support for the task force's upcoming work, and welcomes any organizations interested in becoming sponsors.

Task Force Events and Updates Webpage

Steve continues to add information relevant to the task force on the Events and Updates webpage of the task force website. Steve includes a link to this webpage/newsletter in his e-mails to the task force, and strongly encourages task force participants look at this webpage regularly for important information on programs (e.g. federal grant programs), events, and contacts. Steve regularly updates this webpage with new announcements and activities of interest to the task force.

Task Force Participants List

Steve noted that the task force participants spreadsheet is located on the task force website. Steve again asked attendees to fill out the Google form on the website to be included in this

spreadsheet. This is a good place for task force participants who are looking to connect with others on the task force.

Attendees at task force meetings showing their position and contact information are also included in an Appendix of each task force meeting report.

“Kibitzing with Colleagues” Sessions

Steve stated there are now “Kibitzing with Colleagues” sessions held immediately after the Monday morning task force meetings, where task force participants can informally talk, share, or collaborate on any topics of interest. There will be no agenda, no presentations, and no specified ending time for these sessions.

Database of Presentations at Task Force Meetings

Henry Goldberg constructed a database/spreadsheet of all the presentations (Digital Access Resource Highlights) delivered at our AZBSN COVID-19 Digital Access Task Force Meetings since the task force began operating on March 23, 2020. There have been 46 presentations delivered over the past 18 months through August 30, 2021. The database shows the presentation topic, brief description of the presentation, and the presenter for each meeting.

Steve will convert this database to a Google Sheet which will be posted on the task force website. The Google Sheet will contain links to the corresponding task force meeting report (where the presentation is summarized) and the PowerPoint presentation (if available) or the meeting recording (if available). This Google Sheet will be updated regularly with new presentations that have been delivered.

Arizona Digital Inclusion Directory

Cindy Hogan reported that she is working with Nicole Umayam of the Arizona State Library to prepare an Arizona Digital Inclusion Directory that will be posted on the Connect-Arizona website. This is intended to be a one-stop place where one can find any organization doing work on digital inclusion in the state. Cindy and Nicole are sending out introductory e-mails to invite relevant organizations to be listed in this directory.

Steve commented there are a number of organizations participating in our task force that are working on digital inclusion, and he wants to work on networking these organizations. The Digital Inclusion Directory will be valuable to inform organizations around the state of who is working in this area, encourage collaboration, and avoid duplication of work.

Seniors Digital Inclusion Meetings

Cindy Hogan reported that she is working with AARP of Arizona and the United Way of Tucson & Southern Arizona on organizing efforts to provide digital inclusion services to seniors in the state, and they will be having meetings to discuss this.

Chicanos Por La Causa Applying for EDA Grant

Robert Alvarado, Vice President of Information Management & Technology Management for Chicanos Por La Causa (CPLC), reported that CPLC is looking into applying for an Economic Development Administration (EDA) “Build Back Better Regional Challenge” Phase 1 planning grant (as discussed at the August 30th task force meeting). CPLC has had initial meetings with a group of partners to discuss this. They will be working to determine the focus of this grant, with telemedicine as one possible area under consideration. There will be two meetings this week to continue discussing this.

Steve commented that CPLC is a great organization that works in the five states of Arizona, California, Nevada, New Mexico, and Texas.

Updates: State Broadband Director, AZ State Library, ADE and The Final Mile Project, ACC, Sun Corridor Network

State Broadband Director Update

Jeff Sobotka, State Broadband Director at the Arizona Commerce Authority (ACA), reported on his recent activities.

Jeff reported that the ACA Rural Broadband Development Grants (RBDGs) program has been pushed out to begin on November 1st. The terms and conditions of this program are still being negotiated.

Lake Havasu City has reached an agreement with ALLO Communications, a Fiber-To-The Premise (FTTP) provider headquartered in Nebraska, to provide 10 Gbps symmetrical Internet service to every address in the city. Jeff noted that this will be the best broadband service provided in the state, and he is a big supporter of this. Mala Muralidharan commented that she would like to look into whether ALLO is eligible to apply for state E-rate grants. Steve Peters commented that a number of new companies are moving into Arizona to offer fiber solutions, and he would like to work with Jeff to provide a directory of such companies. Jeff responded that there are currently about six such companies, but he can only work with Steve on such a directory after the agreements are publicly announced because the negotiations are sensitive.

As reported at previous task force meetings, the ACA retained KPMG as the external consulting firm to provide an update to the 2018 state broadband strategic plan focusing on middle-mile fiber strategy/planning. Mark Goldstein asked Jeff about the timing of the release of the KPMG report. Jeff responded that the final draft of the KPMG report will be ready by mid-October, and the report will be released around November 1st (coinciding with the start of the RBDGs program). Jeff added that the state has announced it will be deploying fiber along I-17 and I-19, and KPMG has examined the ROI of deploying fiber along other state highways and provided new insights on middle-mile fiber deployment.

Jeff will be traveling to northern Arizona this week and southern Arizona next week.

Arizona State Library Update

Mala Muralidharan, E-rate Administrator for Public Libraries at the Arizona State Library, reported on her and Arizona State Library recent activities.

Telehealth in libraries is becoming increasingly important (e.g. with hospital overcrowding in the pandemic) as libraries enable patrons who lack Internet access to connect to their healthcare providers. Libraries may provide space, kiosks, and nurse practitioners for telehealth. The main speaker at a recent SHLB webinar on this topic was Craig Settles, an industry consultant, who has published a guide on providing telehealth in libraries. Janet Major and Mala conducted an Arizona Telemedicine Program "Virtual Office Hours" webinar on September 9th on telehealth in libraries. Janet, Mala, and an NAU telehealth team have been holding meetings over the last month and a half to discuss telehealth in Arizona libraries. Mala has followed up on the SHLB webinar contacting libraries in Indiana and Delaware that are doing telehealth in libraries. Mala is writing a Library Services & Technology Act (LSTA) grant application for telehealth in Arizona

libraries, where nurses/student nurses help patrons in need of telehealth care (e.g. post-operative care) that can also be provided at mobile vans with Wi-Fi access from library parking lots. Shereka Jackson commented that security may need to be guaranteed for such telehealth visits -- Mala responded that they would be using an app that guarantees security and is HIPAA-compliant, and that navigators in the libraries would guarantee security and safety. Mala added that she is interested in offering telehealth in tribal libraries, and Indian Health Services is excited about this.

Arizona has been awarded about \$98 million in E-rate funding for the current funding year, which is about 4.6% of the national amount awarded. The FCC has released its draft eligible services list for 2022 E-rate funding. This eligible services list for E-rate reimbursement still does not include cybersecurity, and many schools/libraries would like this to be included. Initial comments are due on this draft eligible services list by September 27th.

The Arizona State Library continues to work on outreach for the FCC Emergency Broadband Benefit (EBB) program (discussed at previous task force meetings). Arizona currently ranks #9 nationally in enrolling low-income households in the EBB program, with over 173,000 households enrolled. There is still a lot of funding remaining in the EBB program and the low-income households that are eligible has recently been expanded.

The FCC Emergency Connectivity Fund (ECF) program (discussed at previous task force meetings) provides \$7.17 billion in support to schools and libraries for off-campus primarily home connectivity for students, school staff, and library patrons by covering purchases of broadband connectivity and laptops/tablets, Wi-Fi hotspots, modems, and routers. August 13th was the original deadline for applying for the ECF program, and USAC is working on sending out funding commitments. Arizona applied for about \$200 million (\$147 per student), which was #6 nationally in how much was applied for in ECF funding. The FCC will be opening a second ECF application window for 15 days from September 28th – October 13th because the summer vacation period for schools limited time for applications, and there is still \$2 billion remaining in funding for the ECF program.

The FCC will hold an open meeting on September 30th with the following agenda: promoting more resilient networks; stopping robocalls; spectrum requirements for the Internet of Things; and supporting broadband for tribal libraries under E-rate.

Mala noted that she is also participating in the Chicanos Por La Causa EDA grant application meetings.

ADE and "The Final Mile Project" Update

Sophia Mayberry, Project Manager and Technology Policy Coordinator in the Office of the Superintendent of Public Instruction at ADE, reported on recent ADE activities, and Milan Eaton, State E-rate Director at ADE, reported on the Emergency Connectivity Fund applications, "The Final Mile Project", and E-rate.

Sophia reported that she has been sharing the Sun Corridor Network cost-free Eduroam service opportunity with schools.

Milan reported that he has been heavily involved in helping schools with applying for funding from the FCC Emergency Connectivity Fund in the 1st window and upcoming 2nd window (as discussed by Mala Muralidharan above Arizona applied for \$200 million in the 1st window). Milan noted that two of the ECF filings in the 1st window applied for funding to build new broadband infrastructure, and two filings in the 2nd window will apply for funding to build new broadband infrastructure.

Milan reported on “The Final Mile Project” (discussed at previous task force meetings), which is funded by ADE. They had released five RFPs for five different school districts. All five RFPs have received successful bids in demonstrating the proof-of-concept requested, and the Final Mile Project Consortium Board has approved all five projects. They are now trying to build awareness of the successful concepts for last-mile access, and Milan is doing a presentation on this on Friday September 17th. They are interested in extending The Final Mile Project to the school districts most in need of Internet access (e.g. St. Johns in Apache County and in the Little Colorado River area).

Milan noted that he really wants security added to the FCC E-rate eligible services list for schools because education networks should be secure in handling student data.

Steve Peters noted that The Final Mile Project Consortium has a Board of Directors, and Milan added that the Arizona Rural Schools Association has elected this Board. Milan explained that each project is chaired by the corresponding local school district superintendent, which evaluates the RFP bids collected by the consortium and makes local decisions. Milan added that he will manage the associated construction projects. Steve added that some task force participants may be interested in extending The Final Mile Project approaches to communities, and he may have Jerry Crow look at cybersecurity issues.

ACC Update

Lea Marquez Peterson, Commissioner and Chair of the Arizona Corporation Commission (ACC), reported on her and recent ACC activities.

Lea explained that the ACC regulates the utility industry, and has some limited jurisdiction over telecommunications service providers.

Lea reported that she participated in a Center for Public Utilities conference where the following topics were discussed: Eligible Telecom Carriers (ETCs) approvals for getting grants; pole attachments and associated role of public utility commissions; 911 service reliability/redundancy; Lifeline and Emergency Broadband Benefit programs advocacy; coordination of federal broadband funding programs; and President Biden’s need to appoint a 5th FCC commissioner.

Sun Corridor Network Update

Derek Masseth, Executive Director of the Sun Corridor Network (SCN), reported on recent SCN activities.

Derek noted he is excited about working on the Eduroam partnership with schools mentioned above by Sophia Mayberry.

Derek reported that the I-17 middle-mile fiber deployment will be breaking ground by October 1st.

Steve Peters noted that there is a rural schools conference on Friday September 17th in Flagstaff, and Derek may want to participate in that.

Local First Arizona Economic Recovery Center Presentation

Kimber Lanning, CEO of Local First Arizona, presented to our task force on May 10, 2021 on their newly-launched Arizona Economic Recovery Center that will enable more qualified Arizona cities, towns, counties, and non-profit organizations to win competitive federal, state, and foundation grants. Steve Peters asked Katie Boddy, Manager of the Arizona Economic Recovery Center, to collaborate with our task force on helping communities and non-profit organizations with funding, technical assistance, and planning resources for their broadband and digital access initiatives. This is consistent with our task force digital access strategy report to find new funding sources for broadband/digital access in the state. Following is a summary of key points from Katie Boddy's presentation, and the full presentation and meeting recording will be posted on the task force website.

The Local First Arizona "Arizona Economic Recovery Center (AZERC)" began its operations in April 2021, motivated by the new federal stimulus funding for broadband/digital equity and the needs of communities/non-profits to improve the quality and competitiveness of their grant proposals. It is focused on assisting three types of organizations: non-profit organizations, rural communities/municipalities, and tribal organizations.

The AZERC has the following priorities in helping these communities and organizations to compete more successfully for grant funding: finding the right grant fit opportunities, fill resource & expertise gaps by providing a roster of consultants; increase grant submissions; develop grant-seeking skills; improve collaboration and build strategic relationships; improve proposal quality; and benchmark their success against other states.

The AZERC performs the following functions: researches and simplifies grant opportunities; identify funding sources for large and small projects; connects funding sources to communities in need of funding; and provides the capacity for grant writing, facilitation, and project management to ensure high success rates for qualifying communities and non-profits.

They issue a newsletter with a customized list of grant opportunities every Monday. This lists federal, state, municipal, and foundation grants. One can sign up to receive this free newsletter at www.economicrecoveryaz.com.

If a community/organization has identified a grant for which they wish to apply or if they need help deciding on an appropriate grant, the Economic Recovery Center will set up a strategy meeting (may be by Zoom) to discuss the appropriate grant and provide assistance in applying for it in the most effective manner. Their roster of consultants with the necessary expertise (who are paid by the AZERC) can help with grant writing or just provide needed support. The AZERC provides these services/resources free of charge (enabled by its sponsors) to eligible organizations who do not have dedicated grant writing staff, have at least 3 partnering organizations, interest in working on a regional or local strategic plan, and have an idea that can be initiated before 2023.

Katie noted that the Economic Recovery Center has worked with 98 entities in Arizona, found funding sources for 38 of them, and have won funding for 4 of these so far. Katie is happy to make a presentation to any organizations interested.

Steve Peters concluded saying that Katie Boddy is the key contact person for those interested in the Local First Arizona AZERC, encourages task force participants to sign up for their newsletter, and though a lot of broadband infrastructure funding will come from government sources digital inclusion funding may come from other sources where the AZERC can be particularly helpful.

On August 27, 2021, the Federal Communications Commission released the draft Eligible Services List for Funding Year 2022.

Initial comments to the draft Eligible Services List are due on September 27, 2021, with reply comments due October 12.

The FY2022 draft ESL is in WC Docket No. 13-184

On September 9, 2021, the FCC released a Public Notice, announcing that it will expand the school years that will be acceptable for eligibility determination purposes for the Emergency Broadband Benefit Program (EBB). Households that can demonstrate participation in the free and reduced-price school lunch program or school breakfast program for the FY2021-2022 school year will now be eligible for the benefit. The Commission allow proof of enrollment in these programs for either the 2019-2020 or 2020-2021

school year, “given that many schools have been closed since mid-March 2020 due to the pandemic and students may not be enrolled in the programs” in the 2020-2021 school year

Emergency Connectivity Fund: Second ECF Filing Window Opens September 28 and closes to October 13. The initial filing window, which closed August 13, 2021, received requests for \$5.137 billion of the \$7.17 billion Emergency Connectivity Fund Program. . Together with the Emergency Broadband Benefit Program, the Federal Government is investing more than \$10 billion in American students and households, so more Americans can connect, communicate, and use the internet productively. Arizona Applicants applied for \$200M and is 6th Nationally. AZ’s ask was approx. \$147 per student

FCC Open meeting On September 9, 2021, the FCC released a tentative agenda for an Open scheduled for Thursday, September 30, 2021.

- Promoting More Resilient Networks – The Commission will consider a Notice of Proposed Rulemaking to examine the Wireless Network Resiliency Cooperative Framework, the FCC’s network outage reporting rules, and strategies to address the effect of power outages on communications networks.
- Shielding 911 Call Centers from Robocalls. Stopping Illegal Robocalls From Entering American Phone Networks.
- Spectrum Requirements for the Internet of Things – The Commission will consider a Notice of Inquiry seeking comment on current and future spectrum needs to enable better connectivity relating to the Internet of Things (IoT).
- Supporting Broadband for Tribal Libraries Through E-Rate – The Commission will consider rules to amend the definition of library and to clarify Tribal libraries are eligible for support through the E-Rate Program.
